- The Commission will hold a public meeting to consider the Final Environmental Impact Report for, and approval of, the Kings Beach State Recreation Area (SRA) General Plan and Kings Beach Pier Rebuild Project Environmental Impact Statement. (CCR Title 14, § 15096(f))
